



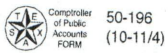

The DELTA COUNTY APPRAISAL DISTRICT will hold a public hearing on a proposed budget for the 2019 fiscal year.

The public hearing will be held on AUGUST 23, 2018 at DELTA CO APPRAISAL DIST, located at 1280 W DALLAS AVE COOPER, TX 75432. A summary of the appraisal district budget follows:

The total amount of the proposed budget. \$ 299,503.00

The total amount of increase over the current year's budget. \$ 22,468.00

The number of employees compensated under the proposed budget. 3

The number of employees compensated under the current budget. 3

The appraisal district is supported solely by payments from the local taxing units served by the appraisal district.

If approved by the appraisal district board of directors at the public hearing, this proposed budget will take effect automatically unless disapproved by the governing bodies of the county, school districts, cities and towns served by the appraisal district.
